Subject: RBWM Draft Borough Local Plan December 2016 - Regulation 18 Consultation

Residents of Oakley Green, Fifield & District,

Most of you will be aware by now that the Royal Borough of Windsor & Maidenhead Council (RBWM) have been working on a Draft Borough Local Plan for a number of years and it is now finally out for Public Consultation.

The Consultation period lasts only 6 weeks – from Friday December 2, 2016 until Friday January 13, 2017.

Bray Parish Council have produced and are delivering a Flier to all Properties in the Parish, but given recent delivery problems in our area, we are attaching it here to make sure you receive it. The Flier only lists the 6 potential Sites for Development in Bray Parish. There are many more across the whole Borough.

To aid understanding, we have also attached here two of the RBWM Maps which show the Sites in our area. There are other Maps for areas such as Cookham, Wraysbury etc.

As part of this Consultation, RBWM will be holding Public Exhibitions where Planning Policy Officers will be available to discuss the Draft Borough Local Plan. These are on:-

Thursday 8 December 3pm – 6.30pm – Maidenhead Library

Tuesday 13 December 3pm – 6.30pm – Windsor Library

Thursday 15 December 3pm – 6.30pm – Ascot Library

The Draft Plan Documents may also be viewed at Bray Parish Office in Moneyrow Green – to the rear of Holyport Memorial Hall – from Monday to Friday between 9:30 and 12:30.

RBWM want as many Residents and Businesses and Organisations as possible to give their feedback on the Proposals in the Draft Local Plan.
